It is agreed that my personal information will not be made publicly available but may only be used directly in relation to the licensing of the Content where necessary (e.g. to defend claims, protect rights or notify trade unions) and may be retained as long as necessary to fulfill this purpose, including by being shared with sub-licensees / assignees of Faces, Places and Things – David Bowden Photography and transferred to countries with differing data protection and privacy laws where it may be stored, accessed and used.
